The Government of Nepal [GoN] has allocated funds towards the cost of Construction of Hasina Simsar Park Wardno:05 and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Hasina Simsar Park Ward no:05 (Contract No: SHM/MOR/NCB/W/51/25077-078). Bidding is open to all eligible bidders as per Section V of Bidding Document
2. Sundarharaincha Municipality invites electronic bids from eligible bidders for the construction of Construction of Hasina Simsar park under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.  
Only eligible bidders with the following key qualifications should participate in this bidding:  
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 43200000 Minimum Work experience of similar size and nature: Participation as Prime contractor, Management Contractor, or Sub Contractor, in at least 2 Contracts within the last ten (10) years, each with a value of at least one Government Tourism Project NRs 5,7500000.00 that have been successfully or are substantially completed and that are similar to the proposed works.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Sundarharaincha Municipality, Morang, Koshi Haraicha, Morang, Province One, Biratchowk, Sundarharaincha Municipality, Nepal or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
5. If hard-copy is allowed then a complete set of Bidding Documents may be purchased from the office Sundarharaincha Municipality, Morang, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 5000.0 NRs. till 28-06-2021 during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). 6. Pre-bid meeting shall be held at Sundarharaincha Municipality Morang Province-1, Biratchowk, at 18-07-2021 10:00 hours.
7. Sealed or electronic bids must be submitted to the office Sundarharaincha Municipality, Morang, Province One, Nepal by hand/courier or through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 28-07-2021 12:00. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 28-07-2021 14:00 hours at the office of Sundarharaincha Municipality Morang Province One, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 2100000 which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
